ABSTRACT

Telangana Motor Vehicles Taxation Act, 1963 – Write off of cumulative arrears of Motor Vehicles Tax to an extent of Rs.76.26 crores upto the period of 30.06.2014 in respect of Three-wheeled Goods Carriages upto GVW of 3,000 kgs and Three-wheeled Contract Carriages (Passenger Autos with seating capacity of 4,5,6 and 7-in-all) and Tractors and Tractor-Trailers used for Agriculture purposes – Orders – Issued.

ORDER:

In the G.Os.1st and 2nd read above, orders were issued for levy of Motor Vehicle tax on three-wheeled Goods Carriages upto GVW of 3,000 kgs and three-wheeled Contract Carriages (Passenger Autos with seating capacity of 4,5,6 and 7-in-all) and for Tractors for Agricultural use and Tractor-Trailers used for Agriculture purposes at the specified rates therein.

2. In the reference 5th read above, the Transport Commissioner has submitted a detailed report and requested the Government to consider to write off accumulated arrears from levy of Motor Vehicle Tax to an extent of Rs.76.26 crores upto the period of 30.06.2014 in respect of three-wheeled Goods Carriages upto GVW of 3,000 kgs and Three-wheeled Contract Carriages (Passenger Autos with seating capacity of 4,5,6 and 7-in-all) and the Tractors for Agricultural use and Tractor-Trailers used for Agriculture purposes.

3. Government after careful examination of the matter, hereby decided to write off the cumulative arrears of Motor Vehicle Tax to an extent of Rs.76.26 crores due upto 30-06-2014 in respect of the four categories of vehicles i.e., Passenger Auto Rickshaws (three-wheeled contract carriages), three-wheeled auto goods carriages, Tractors for Agriculture purpose and Tractor-Trailer for Agriculture purpose under the Telangana State Motor Vehicles taxation Act, 1963.

4. These orders will come into with immediate effect.

5. These orders are issued with the concurrence of Finance Department vide their U.O.No.3132/56/A1/EBS.X/2014,Dated:15.09.2014.
