**O R D E R:**

In the reference 2<sup>nd</sup> read above, the Transport Commissioner, has stated that service charges were prescribed in the department for various types of transactions i.e., taxation, driving license, vehicle registration, fitness certificates and permits etc.. He has also stated that charges are fixed in the year, 2017 vide G.O.Ms.No. 32, TR&B (Tr.I) Department, Dated:06.05.2017 and no enhancement has been made in these charges for the last (8 ) years even though expenditure has increased many fold. Hence, there is need for revision of service charges collected by the department for providing better services to citizens and also requested the Government to issue necessary orders in the matter.

2. Government, after careful examination of the proposal of Transport Commissioner, Telangana State, hereby approve the service charges as indicated in the Annexure to this order and also accord permission to collect the service charges for extending better services to the citizens.

3. The Transport Commissioner, Telangana State, Hyderabad shall take necessary further action, accordingly.
