In exercise of the powers conferred by section 17 of the Telangana Motor Vehicles Taxation Act, 1963 (Act No.5 of 1963), the Government of Telangana hereby amend the existing Third, Sixth and Seventh Schedules under section 3 the of Telangana Motor Vehicles Taxation Act, 1963, as amended from time to time for enhancement of life tax in certain Transport and Non-Transport Vehicles for improvement of Road Infrastructure, Road Safety and better enforcement.
