Attention of the Joint Transport Commissioner, Hyderabad, all the DTCs and all the DTOs in the State is invited to the subject matter and the references cited and it is to inform that Vide G.O.Ms.No.60, dated 12-09-2025 of Tr.R&B (Tr.I) Department, Government has issued orders regarding the implementation of Road Safety measure “vehicle visibility at night time” more effectively by mandating QR based Management Information System (MIS) in affixation of the reflective tapes and rear marking plates for the vehicles for which affixation of tapes is mandatory as per Rule 104 to Rule 104 (E) of CMV Rules, 1989.

In pursuance of the orders issued by the Government, Notification was issued vide the reference 2nd cited inviting applications from eligible Original Equipment Manufacturers (OEMs) for empanelment for affixation of Reflective Tapes and Rear Marking Plates with QR based Management Information System (MIS) on vehicles, as mandated under Rule 104 to Rule 104(E) of the Central Motor Vehicles Rules, 1989, in the State of Telangana.

Vide the reference 3rd cited (A copy enclosed), the following Original Equipment Manufacturers have been empanelled for affixation of Reflective Tapes and Rear Marking Plates with QR based Management Information System (MIS) for the vehicles, as mandated under Rule 104 to Rule 104(E) of the Central Motor Vehicles Rules, 1989, registered in the State of Telangana:

Vide the reference 4th cited, the empanelled OEMs have been issued Authorisation Certificates to undertake the affixation of Reflective Tapes, Rear Marking Plates and Reflectors for the Vehicles as mandated under Rule 104 to Rule 104(E) of the Central Motor Vehicles Rules, 1989, with QR-based Management Information System (MIS) in the State of Telangana as long as the Authorisation is valid. No other OEM, other than empanelled, shall be

permitted to affix the Reflective Tape, Rear Marking Plates and Reflectors for the Vehicles as mandated under Rule 104 to Rule 104(E) of the Central Motor Vehicles Rules, 1989 in the State of Telangana. The details of Authorisation Certificates are as follows.

Work Flow for the implementation of the Road safety measure:

1. The empanelled and authorised OEM, through it's Dealers/ Applicators appointed by the OEM, at each location of Transport Department Offices (list of Dealers/ Applicators of each OEM is enclosed), shall affix the reflective tapes or reflective plates to the vehicles as mandated under Rule 104 to Rule 104(E) of the Central Motor Vehicles Rules, 1989, with a non-destructive hologram with Telangana Transport Department logo and QR code of unique serial number. The hologram/ QR sticker shall be in the following format:

2. Upon affixation of the reflective tapes / retro-reflective plates / reflectors, the authorised Dealer/Applicator shall issue an “Affixation Certificate” containing the following particulars:
 - i. Affixation Certificate Number, Date of affixation & Place of affixation
 - ii. Unique Sl.No. and QR Code

- iii. Name of the OEM, Type approval Certificate details (Number and Issuing Authority), COP details (Certificate Number, Issuing Authority and Validity)
 - iv. Name, Address & Mobile Number of the Dealer/Applicator
 - v. Four (4) photographs of the vehicle taken after affixation, covering all sides, with the front and rear photographs clearly showing the registration number plate
 - vi. Warranty declaration for a minimum period of two (2) years for the products supplied
 - vii. Validity of the Affixation Certificate, which shall be not less than and shall be co-terminus with the warranty period issued by the manufacturer, reckoned from the date of issuance of the Affixation Certificate.
3. The Inspecting Authority shall verify the authenticity of the reflective material by scanning the QR code affixed on the reflective tape/plate or the QR code printed on the corresponding Affixation Certificate using a mobile phone. Upon scanning, the QR-based MIS shall display the complete certificate particulars, including the associated vehicle details, thereby enabling confirmation of the authenticity of the reflective tape/plate and the Affixation Certificate.
4. No vehicle, for which affixation of reflective tapes / reflective plates is mandated under Rule 104 to Rule 104(E) of the Central Motor Vehicles Rules, 1989, shall be issued or renewed a Fitness Certificate without verification of its authenticity through the QR-based MIS System, except in the following case: “Where the vehicle has been recently fitted with reflective tape / retro-reflective plates / reflectors of a make empanelled by the Transport Commissioner and the material so affixed is found to be in good condition”. This exemption shall be available only for a period of three (3) months from the date of issuance of this Circular, after which QR-based verification shall be mandatory in all cases.
5. The Affixation Certificate shall be issued only after ensuring complete and proper affixation of reflective tape and reflective rear marking

plates, strictly in accordance with the prescribed guidelines applicable to the respective category of vehicle. Any “Affixation Certificate” issued in respect of a vehicle, where the reflective tape/rear marking plates/reflectors are found to be partially affixed, improperly installed, or incompletely applied shall be treated as invalid.

6. The Fitness module shall not permit approval of Fitness Certificate unless and until the Inspecting Authority confirms the authenticity of the reflective tape / retro-reflective plates / reflectors through verification in the QR-based MIS System.

The Officers of the Transport Department shall monitor that the Dealers/Applicators/Distributors of the empanelled OEMs do not collect any amount in excess of the prices indicated in the approved Price Chart for reflective tapes / retro-reflective plates / reflectors. The prices specified in the approved Price Chart are inclusive of all charges, including affixation and issuance of the Affixation Certificate. It shall be the responsibility of the empanelled OEM and its State Distributor to ensure that the approved Price Chart is prominently displayed at all affixation centres in a conspicuous place clearly visible to vehicle owners. Any collection over and above the approved Price Chart by the Dealer/Applicator/Distributor/OEM shall be treated as a violation of the conditions of empanelment and shall attract cancellation of authorisation, delisting from empanelment, forfeiture of the Bank Guarantee and such other action as deemed appropriate.

The Joint Transport Commissioner (IT), O/o the Transport Commissioner shall take necessary action to suitably modify the software system to enable sharing of relevant vehicle particulars, namely: Registered Owner Name, Class of Vehicle, Maker’s Name, Variant, and Month & Year of Manufacture, with the empanelled OEMs, for the limited purpose of integration with the QR-based MIS System. The system shall also be configured to receive and capture affixation details submitted by the empanelled OEMs, so as to facilitate verification of authenticity of the reflective tapes / retro-reflective plates / reflectors by the Inspecting Authorities at the time of issue or renewal of Fitness Certificates.

The above system of mandatory QR-based verification in affixation of reflective tape/ retro reflective plates/ reflectors to the Vehicles mandated under Rule 104 to Rule 104(E) of the Central Motor Vehicles Rules, 1989 shall come into force **with effect from 20.02.2026**. From the said effective date, QR-based verification by the Inspecting Authorities, is mandatory for issue/renewal of Fitness Certificates, except in the limited exemption case specified above.

The Joint Transport Commissioner, Hyderabad, all the DTCs and all the DTOs in the State shall follow the above instructions scrupulously and any deviation in the regard viewed seriously. Also, these instructions shall be widely publicised among the Vehicles Owners for strict compliance.

Vide G.O.Ms.No.60, dated 12-09-2025 of Tr.R&B (Tr.I) Department, Government has issued orders regarding the implementation of Road Safety measure “vehicle visibility at night time” more effectively by mandating QR based Management Information System (MIS) in affixation of the reflective tapes and rear marking plates for the vehicles for which affixation of tapes is mandatory as per Rule 104 to Rule 104 (E) of CMV Rules, 1989.

In pursuance of the orders issued by the Government, Notification was issued vide the reference 2nd cited inviting applications from eligible Original Equipment Manufacturers (OEMs) for empanelment for affixation of Reflective Tapes and Rear Marking Plates with QR based Management Information System (MIS) on vehicles, as mandated under Rule 104 to Rule 104(E) of the Central Motor Vehicles Rules, 1989, in the State of Telangana.

Accordingly, the following companies submitted applications within the stipulated time:

The Committee constituted vide the reference 3rd cited, scrutinized the applications, verified the original documents, evaluated compliance with AIS-089 and AIS-090 standards, examined the QR based MIS demonstrations, and also

examined the Price Charts submitted by the applicants, as required under the Notification. The Committee, after detailed scrutiny, submitted it’s verification report in the reference 4th cited, recommending empanelment of the above OEMs and acceptance of their respective Price Charts, as the same were found to be in conformity with the conditions stipulated in the Notification.

Based on the recommendations of the Committee, the following Original Equipment Manufacturers are hereby empanelled for affixation of Reflective Tapes and Rear Marking Plates with QR based Management Information System (MIS) for the vehicles, as mandated under Rule 104 to Rule 104(E) of the Central Motor Vehicles Rules, 1989, registered in the State of Telangana:

The OEMs shall affix the reflective tapes or reflective plates to the vehicles as mandated under Rule 104 to Rule 104(E) of the Central Motor Vehicles Rules, 1989, with a non-destructive hologram with Telangana Transport Department logo and QR code of unique serial number. The Inspecting Authority shall verify the material by scanning the QR code affixed on the reflective tape/plate or by scanning the QR code printed on the corresponding Affixation certificate. Upon scanning, the system shall display

the certificate details, including associated vehicle information, thereby enabling verification of the Reflective tape and certificate's authenticity.

The Price Charts submitted by the above empanelled OEMs, indicating maximum prices for reflective tapes and rear marking plates, inclusive of all charges including affixation, issue of Certificate etc., have been examined and are hereby approved. The approved Price Charts shall form an integral part of these proceedings and are enclosed as Annexure-I. The approved Price Chart shall be applicable to all vehicles in the State of Telangana where affixation of reflective tapes and rear marking plates is mandatory under Rule 104 to Rule 104(E) of the Central Motor Vehicles Rules, 1989, and shall be binding on the empanelled OEMs, their State Distributors, Dealers and Applicators.

Conditions relating to applicability of Price Chart:

1. The prices mentioned in the approved Price Chart shall be treated as the maximum permissible prices.
2. No empanelled OEM, Distributor, Dealer or Applicator shall collect any amount in excess of the approved prices, under any circumstances.
3. The approved Price Chart shall be prominently displayed at all affixation centres at a conspicuous place visible to vehicle owners.
4. Collection of any amount over and above the approved Price Chart shall be treated as violation of the conditions of empanelment, attracting cancellation of authorization, delisting from empanelment and forfeiture of Bank Guarantee, apart from other action as deemed fit.
5. Any revision of the Price Chart shall be permitted only after one year from the date of empanelment or issue of authorization, whichever is later, and only with prior approval of the Transport Commissioner, Telangana.

Other Conditions:

1. The empanelled Manufacturer shall immediately intimate the details of its authorised representative to the Department, whenever there is any change or replacement of the authorised representative. In the event of any misuse, malpractice, involvement in economic offences, or where any criminal charges or complaints are pending or established against the authorised representative, such authorised representative shall be forthwith removed/terminated from representation, and appropriate legal action shall be initiated in accordance with the applicable laws. Depending on the nature and gravity of the offence, the concerned manufacturer may be prohibited from conducting business with regard to affixation of reflective tapes/plates in the State of Telangana and/or blacklisted, until a new authorised representative is duly appointed and notified by the OEM.

2. The empanelled Manufacturer, only after obtaining the Authorization certificate from the Office of the Transport Commissioner are authorised to affix the reflective tapes and rear marking plates on the vehicles in the State of Telangana. The Validity of the Authorization Certificate is One year and it is renewable on production of valid Test Certificate and a valid Conformity of Production (COP) Certificate. The non-refundable fee for issue or renewal of the authorization is Rs.5000/- to be paid in the form of a demand draft drawn in favor of the Transport Commissioner, Telangana. The form of the application for issue/renewal of Authorization is in Annexure-III of this proceedings.
3. The Manufacturer shall provide warranty for a minimum period of two years for the products sold by them. The same shall be mentioned in the Certificate to be issued to the Vehicle Owner at the time of affixation.
4. The Manufacturer himself or through his State Distributor shall appoint Dealers/ Applicators in all locations of Transport Department offices within 15 days of the empanelment. They shall inform Office wise or District wise list of Dealers/ Applicators in the proforma given in Annexure -II of the proceedings.
5. The Manufacturer himself or through his State Distributor shall submit the details of the Dealers/Applicators to obtain/renew the Authorization certificate and they need to inform every time when they terminate a dealer/applicator and appoints a new dealer/applicator to O/o the Transport Commissioner, Hyderabad as well as to the concerned Office of the Transport Department.
6. The Manufacturer shall invariably place at least one Dealer/Applicator in each District, failing which liable for delisting from the empanelment. If any Dealer/ Applicator of a Manufacturer withdraws or unable to provide the service properly in a jurisdiction of Transport department Office, the Manufacturer shall arrange an alternate Dealer/ Applicator in the jurisdiction of the Office of the Transport department within 5 working days.
7. The validity of the Affixation Certificate shall be no less than and shall be co-terminus with the warranty period issued by the manufacturer, reckoned from the date of issuance of the Affixation Certificate. In the event that any Affixation Certificate is issued with a validity period shorter than the applicable manufacturer's warranty period, the concerned manufacturer and/or the Distributor and/or Dealer shall be liable for penalties and/or other punitive action, as prescribed under the relevant rules and regulations. The Affixation Certificate shall be deemed invalid if, at the time of inspection by the Inspecting Authority, the reflective tape or rear marking plate affixed on the vehicle is found to be damaged,

deteriorated, faded, tampered with, or otherwise not in a serviceable condition.

8. The Certificate of Affixation shall be issued only after the reflective tape and reflective rear marking plates are fully and correctly affixed in strict conformity with the prescribed guidelines applicable to the respective category of vehicle. If any vehicle is found to have been issued an Affixation Certificate despite partial, improper, defective, or incomplete affixation of reflective tape and/or rear marking plates, such Certificate of Affixation shall be deemed invalid. Further, the concerned dealer shall be liable to penalties and/or such other action as may be deemed appropriate by the competent authority, in accordance with the applicable rules and regulations.
9. Immediate after empanelment, within no time, the MIS of the OEM shall be integrated with the Database of the Transport Department and the access right without any restriction should be given to the Office of the Transport Commissioner and to any other Officer/Agency authorised by the said office.
10. Manufacturer, whose production of reflective tapes and rear marking plates is found, in violation of AIS 090 or AIS 089 Standards or has been found to supply or certify substandard or imitating type reflective tapes and rear marking plates, the bank guarantee amount will be forfeited besides cancellation of authorization, delisting from empanelment and also the Manufacturer is liable for legal and penal consequences.
11. Manufacturer shall file a police case, immediately after noticing/ brought to its notice by the Transport Commissioner that it's Distributor /Dealer/Applicator is issuing false installation certificates or facilitating installation of substandard product. Also it will be the Manufacturer's responsibility to immediately cancel the login credentials of QR MIS given to the Distributor/ the Dealer/Applicator involved in such activity. If the Manufacturer not acted as above or if the Manufacture himself is involved in such activity, the Manufacturer is liable for cancellation of authorization, delisting from empanelment and also the Manufacturer is liable for legal and penal consequences.
12. Any officer / agency authorised by the Transport commissioner can inspect the stock yard of the Manufacturer / the Distributor / the Dealer about the inventory and other records. The OEMs / Dealers shall keep open the records for inspection by such officer / agency at any point of time.
13. At any stage during the empanelment process or thereafter, the Transport Commissioner may, if deemed necessary, verify the authenticity of the product/samples. The Transport Commissioner shall have the authority

to examine and verify the product's compliance at any point in time. In the event that the sample or product is found to be non-compliant with the prescribed requirements or fails to meet quality standards, the concerned Original Equipment Manufacturer (OEM) will be delisted from the empanelment.

14. The Transport Commissioner, Telangana can terminate the empanelment of the Manufacturer at any time and can blacklist, if it is found violating any of the provisions of the Motor Vehicles Act, Rules & Notifications issued there under and any other instructions issued by the Transport Commissioner, Telangana in affixation of the reflective tapes and rear marking plates.
15. The Transport Commissioner, Telangana can cancel the authorisation and delist any Manufacturer from the empanelment at any point of time without assigning any reasons and without issuing a prior Notice.
16. All other terms and conditions stipulated in the Notification dated 17-11-2025 shall remain unchanged and strictly binding on the empanelled OEMs.
