ORDER:

In the circumstances reported by the Transport Commissioner, Telangana, Hyderabad vide reference read above, after careful examination of the matter, Government hereby agree to the proposal to exempt the Motor Vehicle Advance Tax in respect of Motor Transport Vehicles for the Quarter ending 30-06-2020 & Quarter ending 30-09-2020 in view of COVID-19 pandemic. The Motor Vehicles Advance tax amount already paid for quarter ending 30.6.2020 & quarter ending 30.09.2020 shall be adjusted for future quarters and order that the following Notification shall be published in the extra-ordinary issue of Telangana Gazette dated.31.12.2020.

NOTIFICATION

In exercise of the powers conferred by sub-section (1) of Section 9 of the Telangana Motor Vehicles Taxation Act, 1963, (Act 5 of 1963), the Governor of Telangana hereby grants exemption of tax payable under the said Act in respect of Motor Transport vehicles for the quarter ending 30-06-2020 & quarter ending 30-09-2020. The Motor Vehicles Advance tax amount already paid for quarter ending 30.6.2020 & quarter ending 30.09.2020 shall be adjusted for future quarters.
